 - ii) Current Trade License;
 - iii) Certificate of Registration of Contractors with UPKJ; and
 - iv) UPKJ and CIDB LicensesIf failure to do so, the Council have the right to disqualified the tender.
5. The tenderer shall submit together in a separate sealed envelope clearly marked the **Technical Specification / Commercial Specification, Project Title and Tender No.** , addressed to :-
