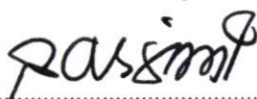

Tender documents are obtainable from the **Contract and Procurement Unit, Level 3, Miri City Hall, Jalan Bandaraya, Marina Bay, Miri** during normal office hours upon payment respective as mentioned above for the document fees (non-refundable) and the tender deposit (refundable) upon receipt of bona-fide tender in the form cash / bank draft / cheque.
3. All **registered tenderers** intending to **purchase or collect the Tender Documents** are **required to produce and submit photocopies of the following relevant documents** for verification purposes:
 - a) **Authorization Letter** from the company (if the person collecting is not the owner or an authorized representative of the company);
 - b) Photocopy of the **Identity Card (IC)** of the person purchase the documents;
 - c) Valid License issued by the **Unit Pendaftaran Kontraktor dan Juruperunding (UPKJ)**;
 - d) **Construction Industry Development Board (CIDB) Certificate**, where applicable;
 - e) **Trade License** of the business, where applicable.Failure to produce the required documents **may result in the application to purchase or collect the Tender Documents being rejected.**
