 - i) **Authorization Letter** from the company (if the person collecting is not the owner or an authorized representative of the company);
 - ii) Photocopy of the **Identity Card (IC)** of the person purchase the documents;
 - iii) Valid License issued by the **Unit Pendaftaran Kontraktor dan Juruperunding (UPKJ)**;
 - iv) **Construction Industry Development Board (CIDB) Certificate**, where applicable;
 - v) **Trade License** of the business, where applicable.

8. Any alteration/ amendment/ correction/ etc. in whatever form shall be accompanied by signature of submitting person otherwise the quotation forms shall be rendered invalid.
